Preceptor Focus

Though they asked that their name not be used, an administrator that has had several AITs felt that they should share an often made AIT mistake. She felt that an AIT internship, unlike some other internship programs, is more about doing than just observing. It's a time to do, learn, understand, and feel the value of the job. There's far more than just learning the book "stuff" to pass the test. It's about learning and understanding the how and why things are done. She suggested the following as a **best practice**.

"The preceptor must continually monitor not only the AIT's learning - but the how and why. She should qualify and quantify that the AIT knows how and why each task/role is done as they move through the different facility departments. It's not enough to know how to do something. One must know why they are doing it. Outstanding preceptors expect outstanding AIT performance".

We should be asking: "Now that you know how to do it, tell why you're doing it and why you're doing it that way?"

This is good advice. The NAB exam requires interpretation while the state is more fact specific. Let's help our AITs by instilling interpretative thinking and a sense of applying the facts at hand.
